The puppies do not have an approved form of identification. All class ``A" dealers shall identify all live dogs on the premises at all times to facilitate record keeping requirements.

HOUSING FACILITIES, GENERAL.

The kennel facility consists of two sheltered buildings. In the first sheltered building there are two open bags of food. In the second sheltered building there are two food containers sitting on the floor. All food must be stored in a manner that prevents contamination and deterioration of its nutritive value. All open supplies of food must be kept in leakproof containers with tightly fitting lids to prevent contamination and spoilage. The dealer must insure all open food is stored in a manner that protects the supplies from spoilage, contamination, and vermin infestation.

Affects eighty adults and twenty-three puppies.

CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

The kennel facility consists of two sheltered buildings. During the inspection there were open food receptacles or bags in both buildings. In the second sheltered building there were rodent dropping under the counter and along the floor / wall junction. The dealer must develop and maintain an effective program for the control of insects, external parasites affecting dogs and birds and mammals that are pests must be established and maintained so as to promote the health and well-being of the animals and reduce contamination by pests in animal areas.
