ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

In the kennel facility there are three sheltered buildings and a whelping building. In building #3 there is one adult female Rat Terrier, chip #4816093C55, whose toe nail on it's left front feet is growing sideways. The dealer trimmed the animals nails during the inspection. In the same building there is a male Jack Russell, chip #392D3B6F75, whose upper jaw teeth are covered in green matter. The animal flinched when inspectors attempted to touch his mouth area. The Jack Russell must be evaluated by the attending veterinarian and the dealer must maintain written documentation of the evaluation and all treatment.

ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

In sheltered building #3 there is one adult female Pomeranian, chip # 473B5B2A6E, which has matted hair through-out it's torso area and around it's anus area. In building #1 there is a male Jack Russell Terrier, named Danny with chip # 983809369, whose lower gum line on both sides are bright red. On the exterior of the same building there is one enclosures containing three adults who have bloody stool under their raised wire enclosure. These five animals need to be evaluated by the attending veterinarian. The dealer must maintain written documentation of the evaluation and all treatment.

Affects five adults.

In the whelping building there are two containers of medications whose expiration date have passed. When a medications expiration date has expired the medication is no longer guaranteed to act as intended and may cause hare to the receiving animal. Expired medication must not be administered to the animals to protect their health and welfare.

Affect one puppy.

CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

The kennel facility consists of three sheltered buildings and one indoor whelping building. In all of the buildings the food receptacles need to be cleaned and sanitized to remove the fly specs, excreta, dark matter, spiders, webs, egg sacs, and or mold on the interior and exterior. Used food receptacles for dogs must be sanitized at least once every 2 weeks and more often if necessary to prevent an accumulation of dirt, debris, food waste, excreta, and other disease hazards.

Affects one hundred ninety-three adults and sixty puppies. Correct by July 17, 2015

REPEAT

CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

The kennel consists of three sheltered buildings and a whelping building. On the interior of all the buildings there is an accumulation of fly specks and spider webs on the light fixtures, pvc support framing, pvc water lines and around the window air conditioner. Premises where housing facilities are located, including buildings and surrounding grounds, must be kept clean and in good repair to protect the animals from injury, to facilitate the husbandry practices, and to reduce or eliminate breeding and living areas for rodents and other pests and vermin.

Affects one hundred ninety-three adults and sixty puppies.
