2.40(b)(2) DIRECT

ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

A female Cavalier King Charles Spaniel, named Buffy (microchip #0A01540960), had a cloudy appearance to both eyes with white discharge on the left eye and tan crusts around the edge of both eyes. The left eye had several blood vessels across the eye, meeting at the cloudy spot. Licensee stated that the dog was seen for this condition several years ago, prescribed a course of treatment but that she was not currently being treated. Eye conditions can be painful and can lead to further complications when left untreated. This condition must be addressed by a veterinarian by close of business Thursday, 12/7/17.

A female Bichon Frise, named Pebbles (microchip #4953134935), had a thinning haircoat and discoloration of the fur around her rump. There were several moist red sores around her tail head. Skin conditions can be painful and uncomfortable. This condition must be addressed by a veterinarian by close of business Thursday, 12/7/17.

2.40(b)(3) DIRECT

ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

A female Yorkshire Terrier, named Paige (4972166F17), had a collar hooked under her right front leg. When the collar was removed, inspectors noticed that the collar had rubbed a deep, open laceration into the right armpit, approximately 2 inches long and 1 inch wide. Open wounds are painful and susceptible to infection if left untreated. Dogs must be observed daily to ensure they are in good health and, if not, addressed in a timely manner with the attending veterinarian. This condition must be addressed by a veterinarian by close of business, Thursday, 12/7/17.
