--The Program of Vet Care was out of date and the last recorded site visit by the attending veterinarian was 9/13/16. Good communication and consultation between the licensee and the attending veterinarian in the form of a written program of veterinary care and regularly scheduled visits to the premises are necessary for the health of the animals. The licensee must schedule a site visit with the attending veterinarian affecting 9 dogs. The licensee must ensure that the program of veterinary care is updated with the current preventative practices to ensure that all animals are provided adequate veterinary care. The program of veterinary care must be made available for review during inspections.

ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

--The right eye of an adult, female, mostly white English Bull Dog is cloudy in appearance and the white of this eye is red in color. This could be due to an infection, allergies, injury, irritation or other medical conditions. The attending veterinarian had not been consulted nor had any treatment been provided at the time of inspection. The licensee stated that this was the first time the eye had been noticed. Eye problems can be painful causing discomfort which affects the health and well-being of the dog. The licensee must have this animal examined by a veterinarian to obtain an accurate diagnosis and appropriate treatment plan. The outcome of this consultation must be documented and provided to the inspector upon request. The licensee must ensure all animals receive adequate veterinary care at all times.
