ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

An approximately 2 year old red female long haired dachshund with no official identification was noticed limping while moving in her enclosure. Upon closer observation inspectors discovered the dog was missing most of her right hind leg. Several inches of a large, dry, yellow-brown bone protruded from the red colored tissue at approximately mid-leg. It appears that all the skin, hair and muscle tissue have been stripped from the bone. The licensee explained that the dog had gotten into a fight with another dog resulting in the loss of the lower part of the right leg. It was not clear how long ago this occurred but based on the appearance of the wound we would estimate several weeks, at a minimum. The licensee also stated that the dog had not been seen or treated by a licensed veterinarian. The licensee has failed to provide adequate veterinary care for this animal. The licensee called for an appointment to their attending veterinarian while inspectors were present, and was directed by the veterinarian to bring the dog in right away. A wound or injury severe enough to cause the extensive damage and tissue loss suffered by this dog would result in severe pain, distress, and the possibility of death due to shock or secondary infections. Licensee must ensure that all the dogs at the facility are observed daily and that adequate veterinary care is provided as needed. The licensee is directed to take this animal to the attending veterinarian by close of business today, and to follow the veterinarian's treatment recommendations.

TIME AND METHOD OF IDENTIFICATION.

The red dachshund female did not have official identification on them at time of facility inspection. The licensee is using collars as the official identification. The letters USDA, the facility USDA license number and individual identification numbers are missing on the collars. Official identification is needed to ensure that each animal's identity can be known with certainty and to facilitate the inspection process. The licensee must ensure that all dogs on the premise have official identification on them at all times. To be corrected by 02-25-2016.
