ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

--In the main building an adult, female Shar-Pei #106 named "Aris" had a red, fleshy protrusion covering almost her entire right eye to the point where the pupil was not visible. It was a moist looking, reddish in appearance, 1" prolapsed growth of tissue protruding from the lower corner of the right eye. It was inflamed, had a milky-green discharge, and was impairing her vision in that eye. This could be caused by infection, allergies, injury, irritation or other medical conditions that could be painful. The licensee stated that this mass of skin had been on her eye for about a year. The licensee also stated that Aris had been seen by a veterinarian within that year, but no improvement had been made to the condition of the eye and there was no documentation proving that a visit to the veterinarian had been made. The licensee scheduled an appointment for Aris to go to the veterinarian the following day (10/27) at 2pm. The licensee must have this animal examined by a veterinarian to obtain an accurate diagnosis and appropriate treatment plan. The outcome of this consultation must be documented and provided to the inspector upon request. The licensee must ensure that all animals receive adequate veterinary care at all times. ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

--In the main building an adult, female Chihuahua #142 named "Ace" had hair loss with inflamed, crusty skin right above the base of her tail about 1.5" wide and 2" long. Skin conditions such as these can be a result of an allergy to fleas or other insects, infection, trauma, or other medical problems and can be painful and itchy. The licensee stated that the hair loss hadn't been noticed prior to the inspection. The licensee scheduled an appointment for Ace to go to the veterinarian the following day (10/27) at 2pm. The licensee must have this animal examined by a licensed veterinarian in order to ensure that an accurate diagnosis is obtained and that an appropriate treatment plan is developed and followed. The licensee must document the outcome of this consultation and make it available to the inspector upon request. The licensee must ensure that all animals receive adequate veterinary care at all times. To be corrected by: 10/28/2017.
