ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

Dog #4243, an adult brown and white beagle housed in room 124 was observed exhibiting a continuous circling behavior to the left. It was not possible to assess this dog in the enclosure without the dog being aware of the observation. However, facility husbandry personnel familiar with the dog stated they were able to observe the dog for approximately an hour each day and the circling behavior was continuous. This repetitive behavior can have behavioral or physical origins.

The medical record of this dog documented circling behavior in April 2012 and enhanced exercise enrichment was provided. It was documented in May 2012 that the dog stopped the circling behavior when group-housed. No additional entries were noted in the record regarding the behavior of this animal.

The dog was individually housed during this inspection and facility personnel stated there was no reason the animal could not be grouped housed at this time. No records were available to determine the dogs housing status between May 2012 and the present. This dog was placed in group housing prior to the end of the inspection.

Dog #4964, an adult female brown and white hound mix, was observed to have thickened pink skin with concurrent hair loss and small crusted lesions in both flank areas at the front of the rear legs. Multiple small red, circular raised lesions were visible on the abdomen in an area where the hair is naturally sparse.

Medical records indicated that this dog had been diagnosed and treated for allergic dermatitis in September and October of 2014 and resolved with treatment. Facility personnel familiar with the previous dermatitis episode stated that the skin symptoms now are not as severe as when treatment was first initiated but are worse than when the prior treatment was concluded.

The current behavioral and physical status of the above dogs should be communicated to and addressed accordingly by the attending veterinarian. Problems related to animal health and behavior as observed by facility personnel must be conveyed to the attending veterinarian accurately and as frequently as necessary to ensure adequate communication related to animal problems is maintained with the veterinarian. Appropriate communication is required to ensure adequate veterinary oversight when needed.
