House Keeping

In the back room where the two hamsters are located, named Mommy and Daddy, there is an accumulation of cobwebs, dust, and debris on the walls and racks. The floor contains spilled feed, shavings, and debris that consist of boxes, wires, and hoses scatter throughout the back room floor. Ineffective cleaning exposes the animals to disease hazards and potential injuries. Animal facilities shall be kept clean and in good repair to protect the animals from injury.

FEEDING.

In the sugar glider room, the first enclosure to the left, the food receptacle has thick brownish material covering the lining of the food receptacle holding two sugar gliders. Inadequate cleaning and sanitizing of receptacles can lead to contamination and potential for disease. Food receptacles shall be kept clean and sanitary at all times.

SANITATION.

Cleaning of Enclosures

In the sugar glider room, the first enclosure to the left, there is an accumulation of feces inside the enclosure on top of a wooden box that is used as a perch that contains two sugar gliders. Excreta should be removed as often as necessary to prevent contamination of the animals contained and reduce disease hazards and reduce odors. The cleaning schedule of this enclosure should be more timely and effective to prevent the build-up of excreta.
