ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

The last documented regularly scheduled visit to the premises, according to the attending veterinarian's records, was in 2007.

The facility must have regularly scheduled visits to the premises by the attending veterinarian. Regularly scheduled visits to the premises are required to ensure that adequate measures are in place to ensure all health issues are addressed in an appropriate and timely manner. Steps must be taken to ensure this noncompliant does not repeat.

ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

"Sassy", a female bobcat was observed with a broken right front leg approximately three inches up from the toes. During the last inspection the foot was dangling and it was clearly broken. There was no broken skin or discharge observed. The licensee stated that "Sassy" had arrived at the facility in this condition and had been seen by the veterinarian. The licensee further stated that the veterinarian said that nothing could be done for the animal. When the licensee was asked for the medical documents, she indicated they were at the veterinarian clinic, but she would obtain them.

On today's inspection the licensee was asked again for medical documentation, but could not provide any. The attending veterinarian was contacted and it was discovered that the attending veterinarian had no knowledge of a bobcat with a broken leg at the licensee's facility. The inspector was unable to view "Sassy" as she was in the area where other bobcats had just given birth and another was about to give birth.

The use of appropriate methods to prevent, control, diagnose and treat animals is a requirement of this section of the Animal Welfare Act. Failure to obtain appropriate veterinarian care for Sassy has caused "Sassy" unnecessary pain and discomfort from the bone on bone contact and may have caused a lifetime disability.
