ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

A female juvenile hedgehog housed in the north side of the showcase enclosure with 4 other weanling hedgehogs was noted to be lethargic, seen to sneeze multiple times, and appeared to have an elevated breathing rate at rest as compared to the other animals. The animal was noted to lay on her sternum or partially curled on her side while the other juvenile hedgehogs were roaming throughout the enclosure and nudging her. The employee was directed by the AC VMO to remove this hedgehog for closer examination. Her breathing had a clicking noise and she appeared weak while being handled. A larger female in this enclosure was also noted to sneeze multiple times, have a clear nasal discharge, and would lick her nose repeatedly after sneezing as well as when she was running in the exercise wheel in the enclosure.

Lethargy, reluctance to move, nasal discharge, sneezing, and abnormal breathing rate and sounds may indicate a severe illness and should be identified quickly so that the animal can be separated from others in case of infectious illness and so the animal can be evaluated by the attending veterinarian as soon as the problem is noted.

****These hedgehogs need to be evaluated by a veterinarian by 9/23/2015 to determine a diagnosis, initiate a treatment**

for the diagnosed condition, and to develop a plan for follow-up to ensure the animal responds to the treatment as expected. Records containing information on the suspected diagnosis, treatment needed, and follow-up plan need to be made available to APHIS inspectors by 9/25/2015.

RECORDS: DEALERS AND EXHIBITORS.

The following records for animals acquired from persons not licensed or registered under the Animal Welfare Act (AWA) did not have all of the required information:

**A female sugar glider acquired on 1/14/2015 had no vehicle license number and State

**Two guinea pigs acquired on 4/15/2015 had no driver's license number and State and no vehicle license number and State

**Two hedgehogs that boarded at the facility (1 on 1/1/15 and 1 on 9/17/15) had no driver's license number and State and no Vehicle license number and State and no date of disposition/return to owner.

**One hedgehog acquired on 5/5/15 had no driver's license number and State and no vehicle license number and State

**One hedgehog acquired on 8/4/15 had no driver's license number and State and no vehicle license number and State

Records of acquisition or disposition were not available during the inspection to account for animals either sold or acquired:

**One chinchilla was sold on 2/21/15 but there was no acquisition record to show when or from where the animal was acquired prior to sale

**Two guinea pigs were sold on 2/3/15 but there was no acquisition record to show when or from where the animals were acquired prior to sale

**A record was reviewed for 1 female sugar glider acquired on 1/14/15 but no record of sale or other disposition was available during the inspection and this animal was not present during this inspection.

**A record was reviewed for 2 guinea pigs acquired on 4/15/15 but no record of sale or other disposition was available during the inspection and these animals were not present during this inspection.

Accurate and complete records for the acquisition and disposition of animals other than dogs and cats are required to

ensure that legal acquisition and humane transportation and care occur.

Every dealer shall make, keep, and maintain records or forms which fully and correctly disclose the following information concerning animals other than dogs and cats, purchased or otherwise acquired, owned, held, leased, or otherwise in his or her possession or under his or her control, or which is transported, sold, euthanized, or otherwise disposed of by that dealer. The records shall include any offspring born of any animal while in his or her possession or under his or her control.

FACILITIES, GENERAL.

There were numerous roaches seen in and around a plastic food container in the back room that held cat food used for feeding hedgehogs. The lid for the container was not secured and there was a hole, approximately 1 inch in diameter, near the top of the container. There was a spider web with a dead roach hanging over the shelf above this and other food containers on this shelf. There were other food items and chinchilla dust stored on a lower shelf with a fly trap lying on top.

Live and dead insects can contaminate the food which may deteriorate the food and may spread infectious organisms to the animals to whom the food is provided. Storing food and grooming items with or near pest control products does not protect such supplies from contamination.

Supplies of food, bedding, and grooming supplies shall be stored in facilities which adequately protect such supplies against deterioration, molding, or contamination by vermin.

SANITATION.

The facility is not effectively controlling insect pests:

**Food, bedding, and grooming supplies on storage shelves in the back room had numerous roaches in and around these items. Spider webs, one with a dead roach above food containers, were also noted in this area.

**Excessive flies were present in the storefront, within the enclosures housing hedgehogs, and in the back storage room where food and supplies are kept. The licensee has fly strips hanging in these areas, as well as a single fly trap near the cash register, but all of the fly strips were fully coated with dead flies and an unused fly trap was found stored with food and grooming materials in the back room.

Insect pests are a source of bacteria, viruses, parasites, and other possible infectious organisms. Flies can also spread disease from one enclosure to another by landing on excreta, or other possibly infectious material, and then landing on the food and water receptacles or directly on the animals in the enclosures.

A safe and effective program for the control of insects, ectoparasites, and avian and mammalian pests shall be established and maintained.

An effective method to control these pests must be implemented and maintained by 9/30/2015.
