2.40(b)(2) DIRECT

ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

***There was a pig in an outdoor enclosure that had an approximately 3-4 inch laceration behind the front right leg. Additionally the animal had several swollen mammary glands on its left side. The licensee stated that this animal currently has mastitis. This animal is currently not being treated and the attending veterinarian has not been contacted. Injuries that are not treated maybe painful and can lead to prolonged suffering, infection, and other veterinary care health problems.

***One pig in the finishing house had a very thin body condition as evidenced by visible ribs as compared to litter mates. The animal appeared to be lethargic and reluctant to move compared to its litter mates. The licensee stated that he had been treating the animal for three weeks with no change in condition. He stated that he had not contacted the attending veterinarian regarding this animal. Thin body condition can signify inadequate nutrition or other underlying disease or pain.

The licensee must have these animals evaluated by a veterinarian by 5:00 p.m on June 26, 2015, to obtain accurate diagnoses and appropriate treatment plans for the issues cited above. The outcome of this consultation must be provided to the inspector upon request. This documentation should include the veterinary diagnosis, all diagnostic tests and the outcome of those tests that were performed by the veterinarian, any medications prescribed along with the dosing instructions, and entries on a log and/or calendar and/or animal health record that list when the medication is administered to the animals.

There should also be an entry at the end of the treatment to document the health status and condition of each animal at that point, to indicate a time frame to address current issues that require further veterinary treatment, and the need for follow-up and any further veterinary care prescribed.

3.125(a)

FACILITIES, GENERAL.

***In the farrowing house there was a hole in the crate flooring underneath the sow with a litter of baby pigs less than 10 pounds each. The hole in the crate floor was approximately 6"x5". Failure to maintain crate flooring in a structurally sound manner can cause injury to the animals by falling through the hole or a leg entrapment. All structures must be maintained and kept structurally sound. The affected structures must be repaired or replaced. To be corrected 6/25/15.

FACILITIES, OUTDOOR.

***The enclosure housing 15 adult pigs did not have adequate shade to protect all of the animals from direct sunlight. The shade structure was approximately 10' x 10' and was not adequate size for all the animals to be in the shade at the same time.

***In another enclosure housing 24 pigs did not have an adequate area for shade. The provided shade area was approximately 3-6 inches deep in mud. There was no area of shade provided in which the animals could remain dry.

Failure to provide adequate areas of shade may lead to animals overheating and discomfort. When sunlight is likely to cause overheating or discomfort of the animals, sufficient shade by natural or artificial means shall be provided to allow all animals kept outdoors to protect themselves from direct sunlight.

FEEDING.

***The feed receptacles in several out door pens were contaminated with dirt, feces and other debris. Dirty food receptacles that are contaminated may harbor pathogens that can contaminate feed that can lead to animal health issues. Food receptacles shall be placed so as to minimize contamination to protect the health of the animals and shall be kept clean and sanitary at all times.
