Watering.

In one cage containing two guinea pigs the water bowl was almost empty and contained feces and bedding. When clean water in a new larger bowl was provided the two guinea pigs drank rapidly and continuously for over a minute. Dirty water that contains fecal material may reduce the potability of the water and can present a health risk to the animals. Clean water must be provided daily, and all water receptacles must be kept clean and shall be sanitized at least once every 2 weeks to ensure the health of the animals. The licensee must develop and maintain a program to ensure that animals have daily access to clean water.

Date to be Corrected: This was corrected by the facility representative at the time of inspection.

Feeding.

In two separate cages containing five hedgehogs in each cage and in two other separate cages containing eight sugar gliders in each cage, there were dirty food bowls with caked on debris and food on the interior sides and along the outside. Adequate measures should be taking and to prevent molding, contamination, and deterioration or caking of food. Food receptacles should be kept clean and sanitary at all times for the overall health and well-being of the animals.

Sanitation.

In two separate cages containing five hedgehogs in each cage and in two other separate cages containing eight sugar gliders in each cage, there were dirty plastic exercise wheels covered with caked on feces. The removal of excreta and the cleaning of the cages and the materials within them must be done as often as necessary to prevent contamination of the animals contained therein and to minimize disease hazards and to reduce odor. Adequate measures must be taken and maintained to promote the overall health and well-being of the animals.
