There were two open bags of food, two open plastic food containers and an open bag of bedding material in the back storage room. A majority of the floorspace in this food storage area needed general housekeeping, sweeping, and cleaning. Open food and bedding supplies stored in unkept areas attracts vermin or other pests which may transmit disease and contaminate the food. Supplies of food and bedding must be stored in facilities which adequately protect such supplies against deterioration, molding or contamination by vermin to ensure the health and well-being of all the animals. A system of food and bedding storage which adequately protects these supplies must be in place.

### 3.131(c)

#### Sanitation.

The back room of the facility which is used for storage of animal food, bedding and other supplies is in need of general housekeeping and cleaning. There was an accumulation of debris, discarded materials and loose papers and boxes covering the majority of the floorspace. Regular cleaning/housekeeping is necessary to prevent the harborage of pests and to reduce the potential for spread of disease. The premises must be kept clean and in good repair in order to facilitate the required husbandry practices and to protect the health of the animals.
