ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

At time of inspection, the facility did not have an up-to-date, written Program of Veterinary Care(PVC) signed by the current attending veterinarian - the previous attending veterinarian retired in December 2017 and is no longer in practice at the hospital listed on the PVC. The PVC must be reviewed, updated, and completed as necessary to accommodate new veterinarians, animals/species, facility changes or changes in husbandry practices. The current attending veterinarian must make a site visit, review the program of veterinary care, and sign and date the forms.

FACILITIES, GENERAL.

In Barn 3 there were large rabbit feeders where the lip of the feeder that contains the feed was worn to a jagged rusty edge. In some cases, the rabbit was even stepping on the jagged edge to investigate their environment. The housing facilities, including the feeders within the primary enclosures shall be structurally sound and maintained in good repair to protect the animals from injury. There is a potential for injury to the face or feet of the rabbits from the ragged and rusty edge of the feeder, and these feeders must be repaired or replaced.

SANITATION.

In at least two enclosures in Barns 1 and 3, there was an excessive accumulation of hair and feces on the floor or side of the rabbit enclosures. Primary enclosures shall be kept reasonably free of excreta, hair, cobwebs, and other debris by periodic cleaning. The cleaning schedule for this enclosure is inadequate, as evidenced by the build up present. The cleaning schedule of this rabbit enclosure should be more effective to prevent the build up of excreta.
